Tensions within global governance structures heightened this year, which has been associated with decreasing pursuit of collective action. Following trade wars between China and the USA that started last year, politicians in London succeeded in alienating Great Britain from the European bloc. Citizens in Hong Kong rebelled against expansion of influence from Beijing, and global attention was drawn to the burning Amazon, with its potential implications for the changing climate.

In Africa, we need to consolidate our democratic gains by deepening participation in policy processes. But how to achieve this has become an arduous task for most governments, whiles some others have considered it a mirage.

These have however not weakened our determination to work towards development processes around the continent that are fueled by evidence-informed policies. Rather, they have strengthened our resolve to maximize resources available to us, and get innovative in our programming.

Working with our partners – both operational and beneficiary – we have demonstrated that resource constraints are just a microcosm of the daunting challenges we are faced with. From our performance this year, we have firm conviction that we are progressing steadily in realizing targets for our strategic foundation. At this pace, we will be ready post-2022 to strategically expand into other sub-regional groupings.

BACKGROUND

On 2nd March 2017 we were registered in Ghana to operate as a company limited by guarantee, and specifically as the Centre for Knowledge Management and Research.

To enable our recognition as a not-for-profit nongovernmental organisation, we also acquired registration from the Social Welfare Department of the Ministry of Gender, Children and Social Protection (MoGCSP) in 2018.

We operate as a youth-led think tank to improve public sector management through information systems research, knowledge management and advocacy for evidence-informed policy making (EIPM).



VISION&MISSION

As a pan-African organisation, our vision is a Pan-African development process that is fueled by evidence-informed policies. Our mission therefore is to influence the use of research and other forms of knowledge in the development of policies in Africa.

OBJECTIVES

We operate to achieve the following objectives:

- Conduct research into information systems, with the view of optimising performance;
- Manage knowledge effectively for improved uptake in policymaking and development practice; and
- Advocate for Evidence-Informed Policy Making (EIPM) in its operational areas



ORGANISATIONAL CHART




Figure 1: Organisational Chart

In our foundational years (2017-2022), we decided to operate based on the organisational chart depicted in Figure 1. In this framework, we have secured a functioning Administration (secretariat) under the leadership of the Executive Director, who also oversees operations within the three functional areas of the organisation: information systems research, knowledge management and advocacy units.

The ensuing sections of this report outlines the extent to which these and many more were achieved in the third year of our operation.

BUSINESS ACTIVITIES



This section emphasizes on the key activities that were embarked on as an organisation.

Income Generating Activities



This year, the organisation's source of income was mostly from consultancy services. One of those services was rendered to the Westminster Foundation for Democracy (WFD), and aimed at ensuring that the country works incrementally to make its governance systems open, transparent and inclusive The organization also received funding from the University of Southampton to organize a workshop to enhance health policy making, governance and research in Ghana.

Non-Income Generating Activities

The ensuing activities constitute those mostly embarked upon without express quest for income expansion.

Capacity Building



Adhering to our quest to improve uptake of knowledge resources and also to champion evidence informed policy processes, especially within public policymaking and practice organisations, we have been involved in some capacity building efforts. Some platforms explored for such activities in 2019 are:

- Co-hosting the 2019 edition of Africa Evidence Week with the Parliament of Ghana, under the regional leadership of the Africa Evidence Network based in Johannesburg, South Africa.
- Initiating a pilot of our Matrix developed from the Context Matters framework produced by INASP and Politics and Ideas. This tool helps government agencies identify opportunities for further action on evidence use.
- Participating as a delegate in the 2019 Evidence2Action conference organised by the International Center for Evaluation and Development (ICED) in Ghana.
- Negotiating for a familiarization workshop to be organised by the Consortium of Academic and Research Libraries in Ghana (CARLIGH), and supported by CABI in the first quarter of 2019.

STAFFING ISSUES

STAFF AND ASSOCIATES

The organization had four operational staff in this year, the Executive Director, an administrative support officers and a volunteer. Table 1 provides their details:

LOGISTICAL ISSUES

Our organisation continued to share the office facility at #12 Mango Tree Avenue, Asylum down (Accra), through an arrangement with a partner for-profit management consultancy firm at no direct fee. The offer came with access to internet connectivity and other office infrastructure.

Official telephone communication was however provided through the mobile number of the Executive Director. This is expected to change, particularly with an expansion in staff strength and with improved financial resources.

The organisation started drafting a policy on financial crime, which is about 80% percent complete. Another draft document was started for financial management policies and procedure, which is about 50% complete.

Our website was also redeveloped to reflect progress in our engagements and advocacy for evidence-informed policy making, knowledge management and information systems research.

CERTIFICATION

The organization was unable to renew the following certificates for its operation due to incomplete annual reports of preceding years among other requirements. These include:

- Certificate of Recognition from the Department of Social Welfare.
- Jurisdictional Certificate of Registration as an NGO by the Accra Metropolitan Assembly.

COMMUNICATION

Communication was vital to our operations in 2019. We took advantage of traditional, interactive and/or mediated platforms to engage with our audience.

PACKS Africa employed different media to achieve them within the period under review. Below are some communication media deployed in 2019:

REACH & VISIBILITY

Following the organization's continuous activity in knowledge management and advocacy for evidence informed policy making, this has contributed to a number of acknowledgements in promoting our identity and reach.

- Our Executive Director was appointed to be part of the advisory group of the AEN.
- Two of our collaborators, Ebenezer Appah-Sampong (EPA) and Koku Awoonor-Williams (GHS) from Ghana were nominated for the Africa Evidence Leadership Award.



MONITORING, EVALUATION & LEARNING

Value Added Services

Information Systems Research

A consultancy service was rendered to the Westminster Foundation for Democracy (WFD) to serve as a baseline study that explores open government partnership, openness and social inclusion in the parliament of government. This added value to work by our partners involved – WFD and the Parliament of Ghana.



Knowledge Management and Brokerage

The initial pilot of our Context Matters Matrix helped the Parliament of Ghana identify opportunities to channel capacity development for enhanced evidence use within it operations.

A second pilot was initiated to involve the Ministries of health in Ghana and Kenya, as well as the Ghana Health Service for similar benefits. A full-scale project is envisaged to bring different organisations

together for regular and comparative diagnostics.

We negotiated for a National Familiarization Workshop to be organised among relevant stakeholders on access to scholarly publications from CABI. The workshop helped various library officers, postgraduate students and other similar users across research and academic institutions in Ghana learn how to access various electronic resources.

Advocacy for Evidence Use in Policy Process

We consolidated our longstanding relationship with the Inter-Departmental Research and Information Group (IDRIG) of the Parliament of Ghana into our partnership to host the 2019 edition of Africa Evidence Week.

Through this event, participants understood different initiatives by different stakeholders to promote evidence use, whiles developing specific skills to enhance their use of evidence.

Our participation in the Evidence2Action conference organised by ICED helped

participants to understand key variables that promote or inhibit evidence use within the context of organisations. We facilitated a workshop in collaboration with the University of Southampton to enhance health policymaking, governance and research management in Ghana.

Participants included representatives from the Ghana Health Service, University of Southampton, Ministry of Health, Ghana College of Physicians and Surgeons, and the National Identification Authority.

DEEPENED COLLABORATION



Through our consultancy services and the resulting impacts thereof, we have good relationship with the Westminster Foundation for Democracy and the Parliament of Ghana for our parliamentary support initiatives.

There has been an entrenched

relationship with the University of Southampton who has been a major micro-funder and collaborator of most events we have organized.

Most of our events have benefited government Ministries, Departments and Agencies (MDAs); and this has led to significant growth in our relationships with these institutions.

We maintained our bourgeoning relationship with the Ministries of Health across Ghana, Kenya and Ethiopia; and took further ecosystem exploratory action through the Bamafirnde team for francophone West Africa.

ORGANISATION DEVELOPMENT

Once more, we took seriously initiatives to further our internal development. Specifically, we;

- Maintained compliance for our organisation within the statutes of Ghana.
- Enhanced competencies for staff performance in our thematic areas.
- Improved recognition within our thematic areas, both locally and internationally.

 Increased availability of knowledge on our thematic issues based on our publications and knowledge sharing initiatives.


